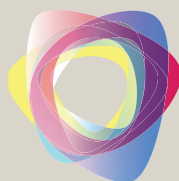

Same Day Surgery

Your doctor has scheduled you for surgery at Pierce Street Same Day Surgery which will enable you to return to the comfort of your own home shortly after your procedure. You will enjoy the highest quality of care provide by a professional, caring staff in a comfortable atmosphere and at a lower cost than any of the area hospitals.

It is important for you to know what to expect before, during, and after your procedure. Following these instructions should help to make your stay more pleasant and a smoother path to a faster recovery.

How to Prepare

On the day prior to your surgery, a nurse from Pierce Street Same Day Surgery will contact you by telephone. For Monday surgery, you will be called on Friday. The purpose of this call is to:

- Tell you when to arrive at the Surgery Center, usually 1- 1½ hours prior to your surgery. (You may be asked to come earlier if additional testing is ordered by your physician.)
- Instruct you how to prepare for your procedure.
- Obtain information about your health history.
- Obtain the names of medications (prescription and nonprescription drugs) you are now taking. You will also be asked about the amount, how often, and why you are taking them.
- Obtain a list of your allergies.
- Obtain information about your previous surgeries, including any problems you may have had after receiving anesthesia. It is also helpful to know if you or anyone in your immediate family has a history of problems with anesthesia.
- Obtain your demographic and insurance information.

The Night Before Surgery

It is important that you **do not eat or drink anything after midnight** the night before surgery, unless you have been instructed otherwise. For individuals having afternoon surgery and for children, instructions when to stop eating and drinking may be different.

- It is alright to brush your teeth and rinse your mouth with water. Be especially careful with children, so that they do not accidentally eat or drink anything.
- Do not take any medications after midnight before surgery unless you have been instructed to do so. If you are diabetic and require insulin, do not take your insulin, but please bring your insulin and glucometer with you.
- If you smoke, try to decrease or stop smoking before surgery.
- Please take a shower or bath using an antibacterial soap and shampoo your hair. Do not use any lotion, cream, or oil in your bath or applied to your skin. Please do not shave around the surgical site.
- You may be asked to remove any nail polish or artificial nails for certain surgeries.
- All piercings **MUST BE REMOVED** before surgery.
- For your safety after receiving anesthesia, sedatives, or pain medications, you must arrange for a responsible adult to drive you home.
- Please arrange for someone to stay with you on the night of surgery.
- Please leave all jewelry and any valuables at home but remember to **bring a photo ID and your insurance card**.
- Other specific instructions will be given to you by the Pierce Street Same Day Surgery nurse the day before your surgery.

If There's a Problem

If a change in your general health develops before surgery, such as a cold, persistent cough, fever, or any health problems, please notify your doctor immediately.

Day of Surgery

Pierce Street Same Day Surgery is located at 2730 Pierce Street directly across from Unity Point Health-St. Luke's. The parking lot is located just off the front entrance of the Surgery Center. If that lot is full, you may park in the parking ramp located directly behind the Surgery Center. Valet parking is also available at no charge for your convenience. For further directions you may refer to the maps in the back of this booklet.

Enter the Surgery Center and check in at the reception desk. At this time your insurance card will be copied and your registration papers signed. Please remember to bring your driver's license or a government issued photo ID. **Any copayment required by your insurance will be collected at this time.**



Pre-Operative Care Plan

You will be prepared for surgery and will also recover from surgery in one of our 21 private patient suites. Your temperature, pulse, and blood pressure will be taken before you go to surgery. The nurse will explain what to expect for the remainder of your stay and discuss methods of controlling pain after surgery. This is a good time to ask questions and discuss any concerns you may have.

Before you go to surgery, you will be asked to put on a gown and remove any dentures, hair pins and accessories, jewelry and contact lenses. If you wear contact lenses, please bring a contact lens case with you. Rings should be removed, if possible, and all body piercings must be removed. Hair in the area of your body where the surgery will be done may be shaved or trimmed in the pre-operative area or operating room.

The Operative Consent

A nurse will ask you to carefully read and sign your consent for surgery. If you are under 18 years of age and not married, your parent or legal guardian must sign for you. A guardian must bring the legal documents showing proof of guardianship along on the day of surgery.

Anesthesia

Anesthesia keeps you from feeling pain during surgery. Before your operation, a doctor specializing in anesthesia will visit with you. The anesthesiologist will ask about your health, medications you take and previous surgeries. It is important to tell the anesthesiologist if you or any of your family members have had problems with anesthesia in the past.

The type of anesthesia you receive will be decided by the anesthesiologist and your surgeon. This will be discussed with you before surgery.

Going to Surgery

Approximately 15 to 30 minutes before your surgery is scheduled, you will be taken back to the operating room. Remember your scheduled surgery time could change as it is an estimated time.

Before going to surgery, the anesthesia staff will visit with you. Anesthesia staff will be with you throughout your surgery. An intravenous (I.V.) line will be started to administer medication, antibiotics, and fluids. Medications to help you relax are usually given before the procedure, after your I.V. is started. The medication will usually make you feel drowsy and less anxious.

In the operative room, you will be greeted by a surgical nurse and monitoring devices will be applied on different parts of your body. This special equipment will be used by the anesthesia team to check your blood pressure, pulse, and breathing throughout the surgery.

When your surgery is completed, you will be moved to the Post Anesthesia Care Unit (PACU or Recovery Room). Your vital signs will be watched closely by nurses until your condition is stable. You will then be moved to our beautiful and spacious Same Day Surgery Recovery Unit. If you do not require monitoring in the PACU, you will go directly to the Same Day Surgery Recovery Unit.

After Surgery

Upon arrival to the Same Day Surgery Recovery Unit, the nurse will continue to check your vital signs, surgical site, and overall condition. It is normal to feel sleepy after anesthesia. The sleep helps your recovery. When you awaken, you may have something to eat and drink. The amount of food you eat depends on how you feel. The nurse will inform you what is available.

Tell your nurse if you are nauseated or need medication for discomfort. Until you are fully awake and able to drink, the pain medication will be in the form of an injection through your I.V. You may take a pain pill when you are more alert and taking fluids well.

Depending upon the type of surgery you have, you may have bandages or dressings. Your nurse will explain these to you. Do not be alarmed if you see some bloody drainage.



- If you had general anesthesia, you will remain under a nurse's care in the recovery area until you are awake.
- If you had a local anesthesia, you will rest in the Same Day Surgery Recovery Unit until your doctor determines that you are ready to go home.
- It is normal to feel drowsy or weak for several hours after surgery. It generally takes 24 hours for the effects of an anesthetic to wear off completely.
- Your final recovery will take place at home. No matter the surgery, you need to rest. Do not make plans for that evening, except to relax and get plenty of sleep.
- Eat lightly and do not drink alcoholic beverages or take non-prescription drugs for at least 24 hours after your surgery.
- **Arrange for someone to drive you home and stay with you when you get home.**
- A nurse will call you, after a day or two, to check on your progress and to answer any questions you may have.

Your Family

Your family and friends will be asked to wait in your room or in the Pierce Street Same Day Surgery Waiting Area while you are in surgery. There is a receptionist in the waiting area to assist your family and keep them informed of any delays. **We ask that your family not leave the designated waiting area without informing the receptionist or the nurses.** The Pierce Street Café is located right next to the waiting room along with free Wi-Fi and a kid's play area for your convenience.

Going Home

Since you have undergone a surgical procedure and received an anesthetic, it is normal to feel sleepy and to have some discomfort upon your dismissal. You will be given instructions on how to manage your discomfort at home, diet, activity, care of bandages, and how to contact your doctor if problems develop.

You must be driven home by a responsible adult and have someone stay with you when you get home. No matter how well you feel, someone should be there just in case there is a sudden change in your condition.

If you are not ready to go home by early evening, or in the unlikely event the surgery takes longer than expected, your doctor may arrange for you to be admitted to UnityPoint Health- St. Luke's.

A nurse from Pierce Street Same Day Surgery will call to check on your condition a day or two following surgery. If your surgery is on a Friday, the nurse will call on Monday.

Extended Recovery Care

Pierce Street Same Day Surgery is now offering an Extended Recovery Care program for specific qualifying procedures. If your doctor has scheduled you for Extended Recovery Care, you may stay one night at the Surgery Center while a nurse cares for you. Visitors are welcome until 8:00p.m., and then one person may stay with you overnight. If your family member chooses not to stay, we ask that they return to the surgery center by at least 6:00 a.m. the following morning as you will be discharged early the morning following surgery.

Personal Checklist

- Contact your insurance company to confirm whether pre-authorization is required for your procedure. Failure to do so may result in denial of benefits.
- **Do not eat or drink (even water) after midnight the night before surgery, unless specifically instructed otherwise.**
- Arrive at Pierce Street Same Day Surgery at the time you have been instructed.
- Bring your insurance, Medicare, or Medicaid card, driver's license, or government issued ID.
- Bring test results that your doctor may have given to you.
- Leave jewelry and other valuables at home. Remove all body piercings.
- Wear simple, loose-fitting clothes.
- Bring slippers or warm socks to wear.
- Don't bring pajamas, gowns, or robes as the Surgery Center furnishes special gowns.
- Limit the number of family members or friends that accompany you, so you will be able to rest.
- PLEASE ARRANGE FOR A RESPONSIBLE ADULT TO DRIVE YOU HOME AND STAY WITH YOU THE NIGHT OF SURGERY.

Special Instructions for Parents of Children Having Surgery

Remember that your child should have nothing to eat or drink, including water, after midnight the evening before surgery, unless otherwise instructed by the Pierce Street Same Day Surgery staff.

The Surgery Center features a Kids Play Area. In this area you will find a T.V. and a variety of books for children to enjoy before going to surgery. **A parent or guardian must accompany children and remain in Same Day Surgery at all time during the procedure.**

The parent or legal guardian will be asked to sign a consent for surgery. If you are the child's legal guardian, you must bring the legal documents showing proof of guardianship.

You may stay with your child throughout the entire stay except when your child is in the surgery and recovery rooms.

Please arrange for child care for any other children so that you can give your full attention to the child having surgery. Children should not be left unattended in the waiting areas.

Prior to surgery your child may be given a medication to drink that will help them to relax and cope with the separation from you.

After surgery, infants and small children may sit on your lap or in your arms.

An I.V. may be in place, but can be removed as soon as your child is drinking liquids.

A reassuring toy or blanket may be brought to the surgery center and may stay with your child at all times. If your child takes a bottle, you may want to bring it for use after surgery. If your child is not toilet trained, please bring extra diapers and wipes for use during your stay.

Insurance/Billing

Medical claims will be filed on your behalf to your insurance company. It is a good idea to contact your insurance company or human resources at your employer prior to your surgery to verify benefits coverage and any pre-authorization requirements. You may also receive multiple bills from other providers involved in your care. These may include your surgeon, Anesthesiology Consultants PC, Siouxland Cytology Consultants, Radiology Consultants of Iowa and UnityPoint Health-St. Luke's. Upon receiving your invoice from our facility, you have several options on how to remit payment. Iowa Advance Directives

There are two legal documents that protect your right to refuse medical treatment you do not want, or to request treatment you do want, in the event you lose the ability to make decisions for yourself:

1. The Iowa Durable Power of Attorney for Healthcare is one kind of advance directive. A DPA states whom you have chosen to make health care decisions for you. It becomes active any time you are unconscious or unable to make medical decisions.
2. The Iowa Declaration is your state's living will. A living will is another type of advance directive. It is a written, legal document that describes the kind of medical treatments or life-sustaining treatments you would want if you were seriously or terminally ill. A living will doesn't allow you to select someone to make decisions for you.

Patient Rights

As a patient you have the right to:

1. Become informed of rights as a patient in advance of, or when discontinuing, the provision of care. The patient may appoint a representative to receive this information should the patient so desire.
2. Be treated with dignity and receive considerate and respectful care provided in a safe environment.
3. Remain free from seclusion or restraints of any form that are not medically necessary or are used as a means of coercion, discipline, convenience or retaliation by staff.
4. Exercise these rights without regard to age, race, disability, sex or cultural, economic, education, or religious background or the source of payment for care given.
5. Knowledge of the name of the physician and professional staff who have primary responsibility for coordinating the patient's care and the name and professional relationships of other physicians and non-physicians who will participate in care.
6. Receive information from the physician about the illness, course of treatment and prospects for recovery in terms that the patient can understand.
7. Receive as much information about any proposed treatment or

procedure as needed in order to give informed consent or to refuse this course of treatment. Except in emergencies, this information shall include a description of the procedure or treatment, the medically significant risks involved in treatment, alternate course of treatment or non-treatment and the risks involved in each and to know the name of the person who will carry out the procedure or treatment.

8. Participate actively in decisions regarding medical care. To the extent permitted by law, this includes the right to request and/or refuse treatment.
9. Formulate advance directives regarding patient's healthcare, and have Surgery Center staff and practitioners who provide care in the Surgery Center comply with these directives (to the extent provided by state laws and regulations).
10. Know that you can express a complaint regarding your care or any violation of your rights, and that your doing so will not adversely affect the quality of care provided.
11. Be advised of the Surgery Center's grievance process, should the patient wish to communicate a concern regarding the quality of the care patient receives. Notification of the grievance process includes: whom to contact to file a grievance, and that patient will be provided with a written notice of the grievance determination that contains the name of the Surgery Center contact person, the steps taken on patient's behalf to investigate the grievance, the results of the grievance and the grievance completion date.
12. Change physicians if desired, either within the Surgery Center or another physician of the patient's choice.
13. Full consideration of privacy concerning the medical care program. Case discussion, consultation, examination and treatment are confidential and should be conducted discreetly. The patient has the right to be advised as to the reason for the presence of any individual involved in the patient's healthcare.
14. Confidential treatment of all communications and records pertaining to patient's care and visit at the Surgery Center. The patient's written permission shall be obtained before medical records can be made available to anyone not directly concerned with patient's care.
15. Full disclosure of the privacy policy.
16. Access information contained in your medical records within a

reasonable time frame in accordance with state/federal laws and regulations.

17. Reasonable responses to any reasonable requests made for service.
18. Leave the Surgery Center even against the advice of the attending physician.
19. Reasonable continuity of care and to know in advance the time and location of appointment as well as the physician providing the care.
20. Be advised if physician/Surgery Center proposed to engage in or perform human experimentation affecting the care or treatment. The patient has the right to refuse to participate in such research projects or clinical trials.
21. Be informed by the attending physician or designee of the continuing health care requirements following discharge.
22. Obtain information before scheduled surgery about payment requirements of the bill, regardless of source of payment.
23. Examine and receive an explanation of the bill regardless of source of payment.
24. If eligible for Medicare, to know in advance of treatment whether a healthcare provider or facility accepts the Medicare assignment rate.
25. Except reasonable safety insofar as the Surgery Center's practice and environment are concerned.
26. Have all patient's rights apply to the person who may have legal responsibility to make decision regarding medical care on behalf of the patient.
27. A list of these patient's rights, which shall be posted within the Surgery Center so that such rights may be read by all patients.
28. Receive appropriate knowledge regarding absence of malpractice insurance.
29. Receive appropriate information regarding provider credentialing.
30. Received pastoral care as requested and as appropriate to patient's needs.

All Surgery Center personnel, medical staff members and contracted agency personnel performing patient care activities shall observe these patient rights.

Patient Responsibilities

The care a patient receives depends partially on the patient himself. Therefore, in addition to these rights, a patient has certain responsibilities as well. These responsibilities should be presented to the patient in the spirit of mutual trust and respect:

1. Provide accurate and complete information about present complaint, past illnesses, hospitalizations and other matters related to your health status.
2. Make it known whether course of treatment and what is expected of the patient is clearly understood.
3. Follow the treatment plan established by the physician, including the instructions of nurses and other health professional as they carry out the physician's orders.
4. Keep appointments and notify the Surgery Center or physician when unable to keep an appointment.
5. Accept responsibility for any actions resulting from the refusal to follow treatment or physician's orders.
6. Accept and ensure that the financial obligations of care are fulfilled as promptly as possible.
7. Follow Surgery Center policies and procedures.
8. Be considerate of the rights of other patients and Surgery Center personnel.
9. Be respectful of personal property and that of other persons in the Surgery Center.

Pierce Street Same Day Surgery strives to provide excellent patient care and service. If you should have a concern or a complaint, please tell us so we can work to satisfy your needs. Ask to speak to the Supervisor or the Director of Nursing.

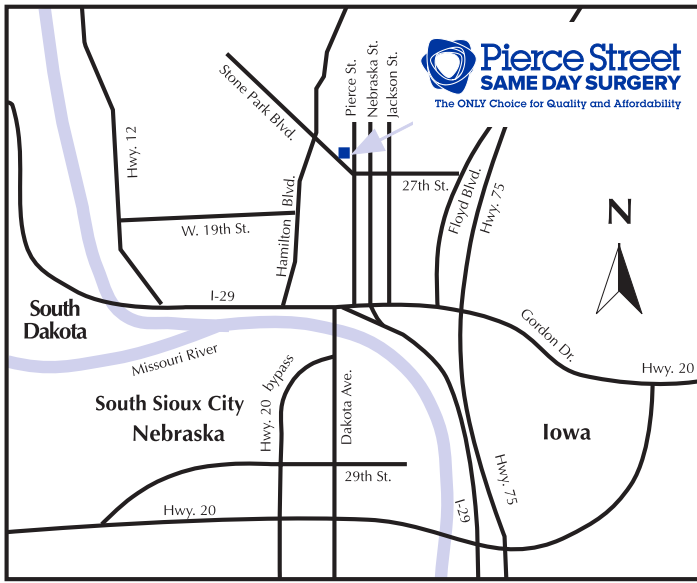
Disclosure of Ownership Interest

Highway directions to Pierce Street Same Day Surgery Center



Highway 12

Take Highway 12 to West 19th, and West 19th to Hamilton Boulevard. Take a left on Hamilton, drive 1 mile, turn right on Stone Park Boulevard. Take Stone Park Boulevard to 27th Street. UnityPoint Health - St. Luke's will be on your left and Pierce Street Same Day Surgery will be on your right.

Highway 75

Take Highway 75 to Floyd Blvd. Exit. Follow Floyd Blvd. and turn right on to 27th Street. At Jones Street jog right, then left. Follow signs to UnityPoint Health - St. Luke's.

Highway 20

Take highway 20 to Business District Exit, follow Nebraska Street to 27th Street. Turn left, go 1 block. UnityPoint Health - St. Luke's and Pierce Street Same Day Surgery will be on your right.

I-29

On I-29, exit at Business District. Follow Nebraska Street to 27th Street. Turn left, go 1 block. UnityPoint Health - St. Luke's and Pierce Street Same Day Surgery will be on your right.

Highway 77

Take Highway 77 Bypass to Dakota Avenue. Cross Veteran's Memorial Bridge on to I-29 South and take Business Exit. Follow Nebraska Street to 27th Street. Turn left, go 1 block. UnityPoint Health - St. Luke's and Pierce Street Same Day Surgery will be on your right.
